Mr. Mike Krzywicki, Apollo Project Manager, presented information in regard to the status of WBASD current projects.

At this time, Denise Thomas stated, Grant Street Property needs to be cleared of junk cars, appraised and sold.

President Caffrey noted there should be a motion made at the March Board Meeting to sell the Grant Street Property.

Report of the Superintendent

Dr. Costello indicated that he was turning over his time in regard to the Superintendent Report to a presentation and statement by Board Member, Rev. Shawn Walker.

At this time, Rev. Walker introduced George Brown, Chairman of the Veterans Wyoming Valley Parade Committee, who introduced the following Veterans of Wyoming Valley essay contest award recipients. Danielle Prudent – Coughlin High School, Ashli Ibarguen Gomez, Meyers High School, Emily Buraczewski, Solomon Plains Jr. High and Mya Corcoran, Mackin at Coughlin High School.

At this time, Rev. Walker presented the following statement:

After the WBASD board meeting on January 29th, 2018, I spent hours thinking about what was said. Certain questions were asked, issues raised and thoughts shared. Some of what was said disturbed me deeply. As the week progressed, it was made clear to me that I wasn't the only one bothered. People who don't usually talk politics with me, people I am only acquainted with at work and in church, teachers and administrators, spoke with me or reached out to me to express concern and disappointment in some of what was said.

I am the type of person who doesn't believe I am always right. I don't believe I know it all, or that my feelings are justified always. So I reached out to a few community leaders to share my thoughts and thought process so that it can be challenged. The goal of these conversations was to provide insight and gain some. I am grateful to those people who spent time talking with me and challenging me.

This evening, I will respond to statements made, provide insight and present a solution. Words are powerful, and because they are so powerful, we must be sure they are accurate. We owe that to the community of more than 60,000 people that make up the WBASD, our 7000 students, their parents and families, and the remaining taxpayers of our district.

This district is absolutely not segregating G.A.R. students. When I first heard that word, personally, I was offended. I was offended because I understand what segregation was. Jim Crow laws. Signs above water fountains saying "for coloreds only". I remember my father sitting me down to watch the documentary "Eyes on the Prize" and other footage of the 50s and 60s. I remember seeing the dogs, the water hoses and other images of a dismal, dark time in our nation's history. Today, our country is on edge. There are many who feel we are going backwards, once again to that dark place. Some feel that rights are being taken away, that lives are being lost unnecessarily, that rhetoric is becoming more divisive and instead of coming together, we are growing further apart. One community leader I spoke to said, "we are on high alert." That phrase provided a different perspective to me. It helped me understand a point of view that was slightly different than my own. I heard and understood their passion. I appreciate and respect the willingness to stand up, and speak up for what you believe in.

Everyone is entitled to their opinion. That is true. But this isn't a matter of opinion. It's a matter of definition. By definition, segregation is the enforced separation of different racial groups in a country, community or establishment. Discrimination, by definition, is the unjust or prejudicial treatment of different categories of people or things, especially on the grounds of race, age, or sex. We are doing neither.

Our district is ranked #1 of 12 most diverse districts in the county, #11 of 405 in the state. Moreover, WBASD is ranked #405 of 10,626 districts in the country. That means we are in the top 3% in diversity in the state and 4% in the country.

Coughlin is 35.65% non-white.

G.A.R. is 73.51% non-white.

Meyers is 64.62% non-white.

Overall, our district is 61.6% non-white.

If we were discriminating or segregating by race, then why merge one of our most non-white schools with a predominantly white school? On the surface, it doesn't make sense. And that is because we are not segregating nor discriminating.

Now, you can argue that G.A.R. staying at their school on the hill is unfair. You can argue there will be inequity in educational opportunities. That debate can be had. But discrimination? Segregation? If segregation was at the root of this merger, I would resign from the board immediately!

The root of this though, is a motion made and passed in June of 2015 to merge Coughlin and Meyers as a result of the district feasibility study. At the time, some members of the community and this board, including myself and Christine Katsock, were arguing for neighborhood schools. The board majority as I understand it, wanted to keep G.A.R. as a neighborhood school. The thought was G.A.R.'s students and parents, would want to remain in their community's neighborhood school.

As time moved on, community members attending school board meetings started using the word discrimination. The argument was made that G.A.R. students should be allowed to attend the new school and benefit from the educational opportunities it presents. I agree.

From the beginning of this process, I have said two things:

- 1. This is a decision between right and righter.
- 2. The Gold plan and Silver plan.

I believed the righter thing to do was to save the neighborhood schools, building a new Coughlin in Plains, renovating or rebuilding Meyers and G.A.R. over a 12-year timeframe. I called this the Gold Plan. If that plan could not be accomplished economically, then the right thing to do would be a full consolidation. This plan I called the Silver plan. The wrong thing to do would be nothing. And so, this district decided to do something.

So then, Coughlin and Meyers are merging.

What about G.A.R.? Over the past two years or so, up to and including last week, we have heard your concerns regarding their inclusion in the new building.

There are three options that address this concern, two current and one I will propose.

- 1. Due to the plancon reimbursement process, we cannot change the motion, allowing for a full consolidation without foregoing the 10M in plancon reimbursement. That said, making such a motion is an option.
- 2. G.A.R. students can enter into the new building the following year without losing plancon reimbursement dollars.
- 3. The third option, which I will propose and be asking for board support this evening, is that the superintendent create a school choice policy, with safeguards around transportation, etc., ensuring that any child and/or parent who wishes to attend or have their child attend the new school within our District will be able to do so the day it opens.

The third option will allow all 9th through 12th grade students the choice to choose which high school they will attend; from the one remaining high school located on Grant Street or the newly constructed high school located on the Pagnotti property.

RESOLUTION OPPOSING ESA VOUCHER PROGRAMS (SB 2) BY THE BOARD OF DIRECTORS OF THE WILKES-BARRE AREA SCHOOL DISTRICT

WHEREAS, Pennsylvania school districts provide countless academic and extracurricular opportunities for learning and growth of all students, preparing them for higher education and careers; and districts have continued to make steady gains in academic achievement, with Pennsylvania students consistently ranked in or near the top 10 nationally on the National Assessment of Educational Progress (NAEP) exams for reading and math; and Pennsylvania has been named a national leader in providing Science, Technology, Engineering and Math (STEM) education programs; and

WHEREAS, Pennsylvania also maintains a greater high school graduation rate and a larger percentage of student moving on to higher education than the national average; and

WHEREAS, more than 80% of Pennsylvania students enrolled in career and technical centers or programs are achieving at the competent to advanced level on industry-based skills assessments, enabling them to earn credentials leading to meaningful employment or college credit equivalencies as cooperating institutions; and

WHEREAS, public schools ensure that each student with a disability receives a Free Appropriate Public Education (FAPE) in compliance with federal and state law and regulations, with students and their families having benefits of a system of procedural safeguards; and

WHEREAS, Education Savings Account (ESA) voucher programs such as those under Senate Bill 2 undermine Pennsylvania's responsibility to ensure every student in every community has equal access to public education; and schools targeted under Senate Bill 2 are already in under resourced districts; and state money for ESAs would be deducted, on a perstudent basis, from a school district's basic education subsidy; and not only would school districts' state aid be sent to unaccountable private schools, but such money could also be diverted to higher education, tutoring services and other "qualified education expenses," not even ensuring students receive full-time educational instruction; and

WHEREAS, the voucher program in Senate Bill 2 benefits families regardless of income or need, including students already enrolled in private school or never having attended a targeted public school; and voucher systems in other states have been shown to be vulnerable to financial fraud and abuse; and

WHEREAS, unlike private schools, public school districts accept, educate and protect the rights of all children who come to their doors, as opposed to those institutions that can reject applicants based on any number of factors and are not required to uphold the rights of students with disabilities; and

WHEREAS, public schools are held to strict accountability standards that measure student achievement and academic progress, unlike private schools which are not required to use the same standard assessments and reporting requirements as public schools; and provisions under Senate Bill 2 would not require participating private schools to use the same standardized assessments, making comparison and evaluation of academic progress unachievable; and

NOW THEREFORE, BE IT RESOLVED: that the Wilkes-Barre Area School District opposes Senate Bill 2 and any other legislation or any effort by the General Assembly to implement tuition vouchers or any other program that would have an effect of a tuition voucher program, and conveys the importance of supporting and improving the quality of all public schools in the Commonwealth.
