

Solomon-Plains Elementary Title I Parent & Family Engagement Policy 2023-2024



The entire process of education is improved when the home and school work together as a team. The Solomon-Plains Elementary School Title I Program values the contributions of parents and families and recognizes that meaningful parent and family engagement contributes to student academic achievement.
