Report of the Superintendent

Dr. Costello presented the following statement.

According to the previous NEA President Dennis Van Roekel – There is no better partnership that exists then the one among Parents, families, educators and communities—to assure that all students, k-12 have the support and resources they need to succeed in school and in life.

According to research, it is clear, consistent, and convincing Parent, family, and community involvement in education correlates with higher academic performance and school improvement.

Researchers cite this type of partnership parent-family community involvement as a key to in improving graduation rate, while creating more motivation among students. The evidence holds true for all students regardless of parent's education, family income, or background—and the research shows parent involvement affects academic achievement across all races.

Support systems in place among all stakeholders for our Academic & Social Service needs of our students is essential in closing the achievement gap. This is considered one of the characteristics common to high performing schools. So Tonight, I would like to thank the new faces for coming to the meeting and I look forward to strengthening our relationship for the overall success of our students.

- Appreciation expressed for all the help provided by WBASD employees in regard to the Easter Egg Hunt sponsored by the South Wilkes-Barre Residents Association that was held at Kistler Elementary School.
- 3. District was not informed in regard to the pros and cons of the six sites initially considered and the Board rejected all six sites.
- 4. The Board paid for other sites to be evaluated and picked the worst site.
- 5. Who was responsible for turning down the land offer provided by Geisinger and why was the public not informed as to your decision?
- 6. Is the Plains site undermined and can the entire site be utilized?
- 7. Every student is entitled to receive a quality education.
- 8. Improve discipline practices and be cautious that minority students are not singled out and are treated equally in regard to matters of discipline.
- 9. The District needs to recruit and hire minority teachers.
- 10. The District needs to prepare students in regard to Career and College readiness.
- 11. The District needs to guarantee that all resources are available to all students.
- 12. The Board needs to address the concerns that the G.A.R. students will not benefit from the new consolidated school.
- 13. The District need to address and eliminate the feeling of G.A.R. students that they are not good enough.
- 14. All students need to feel that they are valuable.
- 15. The Board Room of the Administration Building is an unacceptable location for Board Meetings to be held. The meetings need to be held in the auditoriums of either G.A.R. or Meyers High Schools.
- 16. Issues of public concern in regard to excluding G.A.R. High School need to be addressed. A two school consolidation is a bad plan.
- 17. A single school is not the answer. Community involvement does not happen in a single school and school choice does not promote neighborhoods.
- 18. Meyers and G.A.R. High Schools are sustainable.
- 19. The Board does not listen to the public. People need to attend meetings to level the playing field.
- 20. Students need to be the #1 priority and the Districts plan is not a fair and equitable plan for all students.
- 21. The Board has made school choice an option because your consolidated plan is not equitable.
- 22. Property values and property taxes will decrease due to the District's consolidation plan.
- 23. The members of the internal and external task force recommended using the Meyers High School facility.
- 24. The Board needs to be accountable for the funds they have wasted.
- 25. The Community is concerned about the ranking of the WBASD.
- 26. If the Board does not reconsider their current plan, the Board will not be able to afford any plan.
- 27. Parents will begin to choose Charter and Cyber schools if the Board continues with their consolidation plan and the District will have to pay for Charter and Cyber schools.
- 28. The Board needs to find a three school solution.
- 29. If the Board continues with their plan to renovate G.A.R. High School and build a consolidated school in Plains, residents will begin to leave Wilkes-Barre.
