

## Title I Parent & Family Engagement Policy 2023-2024 Dodson Elementary at Mackin School Wilkes-Barre Area School District



## **Purpose**

The entire process of education is improved when the home and school work together as a team. Dodson Elementary at Mackin School Title I Program values the contributions of parents and families. ## **Components:**
