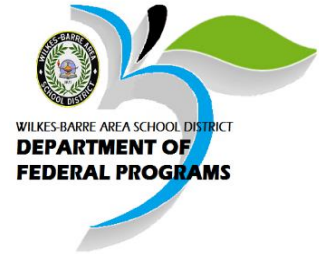




# **Title I Parent & Family Engagement Policy**

## **Objective:**

## **Components:**

The Title I Parent and Family Engagement Policy summarizes how Leo E. Solomon-Plains Middle School carries out the following ESSA requirements cooperatively with parents and families and how the school will:
