- 1. Describe the host's educational oversight to ensure students with disabilities are educated in the least restrictive environment while in the 1306 facility? (If not a host, answer as if you were.)
 - Once a student enters a facility that qualifies under Section 1306, a case worker will register the student with our district by completing the online registration information. Someone from registration will reach out if any additional information is needed and seal the registration. The case worker will then indicate if the student is a special education student. Once the registration process is complete, our special education department will then be notified that the newly registered student falls under Section 1306. The department will then send a request for all special education records to the previous school district. Wilkes-Barre Area School District's Director of Special Education and Special Education Coordinators will then review all special education records and place the student in the most comparable program to the one he/she was most recently in. The IEP team will then implement that program, collect data, and determine the continued appropriateness of that program for the student.
- 2. Describe the district's procedures for communicating with 1306 facilities and how the district ensures a successful transition back to school? The Wilkes Barre Area School District is responsible for monitoring the educational progress, reviewing educational services, and for maintaining contract with the home school district with respect to the student's placement and progress. We are committed to providing FAPE, IDEA compliance, and Chapters 14, 15, and 16 of Title 22 of the Pennsylvania Code to prepare 1306 students to meet any applicable promotion and/or graduation requirements. To facilitate a smooth transition, if the residential facility provides notice that a student is to be released from the facility, Wilkes-Barre Area School District and the residential school district will work together to prepare the student's discharge from the institution at least two weeks prior to the student's planned discharge. If the student is moving to a residential facility in another school district, Wilkes-Barre Area School District will make these same contacts with the new host school district. In addition, the Wilkes Barre Area School District will make sure all records are forwarded to the new district for appropriate placement.

1. Describe the system of oversight the District would implement to ensure that all incarcerated students who may be eligible for special education are located, identified, evaluated and when deemed eligible, are offered a free appropriate public education (FAPE).

The Wilkes-Barre Area School District is following with IDEA and FAPE with regards to incarcerated youth. Wilkes-Barre Area School District will comply with "child-find" obligations and will utilize appropriate evaluation procedures to determine the eligibility and educational needs of the inmates. Once identified, the Wilkes-Barre Area School District will implement and develop an Individualized Education Plan (IEP) in accordance with state and federal laws. Also, the Wilkes-Barre Area School District will obtain information from the PennData database to further determine the inmate's eligibility for special education services. Furthermore, when we receive notification of an out of district student place in the Luzerne County Correctional Facility, the Wilkes Barre Area School District will obtain the special education records and begin servicing the incarcerated youth.

Least Restrictive Environment

- 1. Review the district's data for Least Restrictive Environment. Highlight areas of improvement.
 - Wilkes-Barre Area School District has adopted an inclusionary philosophy. The Wilkes-Barre Area School District Special Education Curriculum is that of the regular education curriculum (which is tied to state standards) with a listing of suggested adaptations and accommodations. This allows those students who are being instructed in the special education classroom the opportunity to transition back into the regular education classroom when they have acquired the skills and strategies to be successful in the general setting. Our approach to inclusion has been most proactive. We currently have inclusion teams in each of our buildings. In addition, there is a district wide inclusion council. These meetings are as a forum to receive new updated information from state, brainstorming problems, exchange of ideas and to establish a unified district approved on certain issues. The district ensures that, to the maximum extent appropriate, children with disabilities are educated with non-disabled children, and that the removal from the regular education environment only occurs when education in that setting with supplementary aids and services, can't be satisfactorily achieved. Pre-referral educational support and special education services are provided in the regular education classroom environment by teachers at all grade levels. Needed special education services are provided within the context of the regular education classroom to the maximum extent possible in order to ensure that students are exposed to and can progress adequately within the regular education curriculum. These supplementary aids and services include but are not limited to the following: adaptations and modifications to the physical environment, modified curricular goals based on individual student needs, alternative ways for students to express learning, test modification, alternative materials and/or assistive technology, instruction on functional skills in the context of typical routines in the regular education classroom, varied methods of presentation, researched-based supplementary materials and instructional adaptations, para professional staff support in the regular education classroom. In addition, the Wilkes Barre Area School District registers over 200 new students a year who already receive special education services, most from out of state, and are placed in the most comparable placement, the district completes an ER and IEP to determine appropriate placement.
- 2. What universal practices does the district utilize to address the academic and social/emotional needs of all students in need of accommodations to their learning environments?
 - The Wilkes-Barre Area School District utilizes the SBBH program for students in grades K-8, social workers, in house outpatient clinics, Rhithm, Kooth and CASSP teams for students with social/emotional needs. The Wilkes-Barre Area School District also works closely with PaTTAN, our Local intermediate unit (LIU 18), neighboring school districts, and a variety of outside agencies to provide training consultation, and technical assistance to faculty, staff, and administration. Members of the Wilkes-Barre Area School District's faculty/staff have received training in a variety of programs, services that include: Dynamic Indicators of Basic Early Literacy Skills (DIBELS); Safe to Say; Mindfulness and Meditation; School-wide Positive Behavior Support; Truancy elimination; and Student Assistance Program (SAP) as well as academic trainings in progress monitoring tools (Aimsweb), remedial reading programs (Transformations, Read to Acheive, Fusion), corrective math programs and supplemental math and ELA program (IXL)
- 3. Describe the academic programming and training efforts the LEA utilizes to ensure meaningful participation of students with disabilities in the general education curriculum.
 - Wilkes-Barre Area School District has worked closely with PaTTAN, our local intermediate unit (LIU 18), neighboring school districts, and a variety of outside agencies to provide training, consultation, and technical assistance to faculty, staff, and administration. Members of our school districts Faculty/staff have received training in a variety of academic trainings in progress monitoring tools (Aimsweb), differentiated instruction, accommodations, modifications, remedial reading programs (Transformations, Read to Achieve, Fusion), corrective math programs and supplemental math and ELA program (IXL).

- 4. Describe the supplementary aids and services the LEA utilizes to ensure meaningful participation of students with disabilities in extracurricular activities. Wilkes Barre Area School District has provided various supplementary aids and services to ensure meaningful participation of students with disabilities in extracurricular activities. These have included: modified practice/instruction time; additional supports to activities that may include a peer buddy and/or adult model; specialized transportation; as well as communication devices and referrals to outside activities and/or supports. As a district, we also participate in the Unified Special Olympics Track Team.
- 5. Describe the District procedures, which ensure that, to the maximum extent appropriate, children with disabilities placed in private institutions are educated with non-disabled children and have the opportunity to participate in district lead extracurricular activities?

 Wilkes-Barre Area School District has worked closely with private institutions to ensure that students with disabilities have the opportunity to participate in extracurricular activities by providing feedback and assistance with modified practice/instruction time, additional supports at activities, specialized transportation, as well as, communication devices. In addition, all information regarding extracurricular activities is shared with the private institutions, students and their families.
- 6. Discuss the district's need to build capacity and expand programs and services in an effort to provide a continuum of services. (Consider the out of district placement chart)
 - Wilkes-Barre Area School District has continuously added to our continuum of programming/services by implementing programming/services at every level K-12 in the areas of Autistic Support services, Emotional Support services, Life Skills Support services, Speech/Language Support services, Occupational Therapy services, Physical Therapy services, as well as Social Work Services. Wilkes Barre Area School District will continue to look to create/improve current programing to assist in providing a continuum of programming within our buildings to reduce the number of students in need of out of district placements.

- 1. How does the district support the emotional, social needs of students with disabilities?

 Students with disabilities shall be educated in the least restrictive environment and shall only be placed in settings other than the regular education class when the nature or severity of the student's disability is such that education in the regular education class with the use of appropriate supplementary aids and services cannot be achieved satisfactorily. The IEP team for a student with a disability shall develop a positive behavior support plan if the student requires specific intervention to address behavior that interferes with learning. The identification, evaluation, Functional Behavior Assessment and plan or program shall be conducted and implemented in accordance with state and federal laws and regulations
- 2. Describe training provided to staff in the use of positive behavior supports, de-escalation techniques and responses to behavior that may require immediate intervention.
 - Wilkes Barre Area School District faculty members receive training from the local intermediate unit in Safety Care. Safety Care provides a comprehensive continuum of prevention, de-escalation and safe emergency intervention strategies for responding to aggressive behavior in schools.
- 3. Describe the district positive school wide support programs.
 - School-wide Positive Behavior Support (SWPBS) is being utilized in several of Wilkes-Barre Area school district's buildings. SWPBS is a team based systematic approach in teaching behavioral expectations throughout the school. It is based on a proactive model which teaches the behaviors, reinforces and recognizes students who are able to model these behaviors, and has systems in place to support students who have a difficult time or may present with more challenging behaviors.
- 4. Describe the district school-based behavior health services.
 - School-Based Behavioral Health Services through Children's Service Center are in all five of our elementary school buildings and in both of our junior high school buildings which consists of master level and bachelor's level counselors in addition to access to crisis teams when needed. The district also operates emotional support classrooms on all levels for students that struggle with behaviors as well as 4 full time contracted licensed school social workers. In the high school there is an outpatient clinic.
- 5. Describe the district restraint procedure.
 - The use of restraints shall be considered a measure of last resort and will only be used after other less restrictive measures, including de-escalation techniques have been attempted. If all de-escalation techniques have been utilized and have been unsuccessful a restraint maybe performed by trained staff. Immediately following a restraint, parents or guardians are contacted and an IEP meeting is scheduled. In addition, the restraint will be reported following proper reporting procedures.

Intensive Interagency

Please address any areas of concern with students who are placed on Instruction Conducted in the Home or who are at a substantial risk of waiting more than 30 days for an appropriate educational placement.

Wilkes-Barre Area School District offers a wide continuum of services and supports for students with disabilities including the following: Itinerant and Supplemental Emotional Support, Itinerant, Supplemental and Full-time Autistic Support, Supplemental and Full time Life Skills Support, and Speech/Language Support. In addition, the district has opened and is planning to open more specialized classrooms within our district buildings. This will limit the need for out-of-district placements. When the districts encounter students that it finds difficult ensuring FAPE to, it would utilize several resources including but not limited to the following: Collaboration with the Luzerne Intermediate Unit and/or programs from neighboring districts. Contact the local county office to coordinate a CASSP meeting to gain assistance with mental health and community resources that can be used to meet the particular needs of the identified student. Contacting the Regional Interagency Coordinator (RIC) to discuss any potential Cordero placements. Coordinate with PaTTAN, Luzerne Intermediate Unit #18, or private organizations to provide training for those teachers who have students with intensive needs in their classrooms. The process that the district uses, and will use in the future, is to bring all service agencies together to collaborate on the "nature" of the particular student. This includes school based services, as well as home based services. Parents serve as an integral part of the process. Suggested educational placements range from least restrictive to more restrictive, but never require "most restrictive".
